**Director Report:** Director Weigle reported that the Neumann Park Project is progressing on schedule. Additional parking near Shelter 2 is complete, and Aupperle is working on grading two new pavilions, restrooms, and splash pad areas. GA Rich will begin installing plumbing for the splash pad and restrooms in the coming weeks.

Opening weekend of Witches Walk was a success. Chief Orr managed traffic control and parking effectively. We expect a good turnout for the second weekend of the event.

The Park District received praise from area coaches and players for the new tennis courts and surrounding facilities. The boys' tennis team plans to hold their Varsity Conference Tournament on our courts next May.

The Trucks and Trades Event was a success. The highlight was the Life Flight helicopter landing in Diamond 1, allowing participants and the community to view the aircraft up close and interact with the flight crew.

The Movie in the Park featured *Monsters Inc.* and attracted over 300 attendees. Special thanks to Mosquito Authority for sponsoring the event and spraying the area beforehand.

The next event will be the Path of Honor – Veterans Day Fundraiser at the Farm Park on November 8<sup>th</sup> and 9<sup>th</sup>. This will be a free event for the public to attend. The profits will benefit the Illinois Valley Fuller Center for Housing to help support local veterans and their families.

**Superintendent Report:** Superintendent Mingus reported that electrical service and surrounding blacktop work are complete at the maintenance storage building. Concrete work in front of the building is scheduled for completion next year.

At Spindler Marina, the outdoor storage and parking area has been cleared, and new striping and numbering for camper and boat storage have been added, an important improvement for better tracking and organization.

Over the past month, the crew has supported community events, prepared for the Witches Walk, replaced concrete around the Diamond 2 concessions building, and winterized the parks.

## **Programs, Facilities and Policy**

**Recreation Programs Report**: Director Weigle reported that the winter session for Sports for Tots Basketball season will start November 10<sup>th</sup> and registration for Youth Basketball is currently underway and will begin in January.

**Police Report:** Chief Orr reported the department has received all Taser 10 equipment and accessories through the ILEAS grant. On September 30, 2025, four officers, including myself, completed instructor-level training and are now certified Taser 10 instructors, eliminating the need for outside training.

Community events, including Trucks and Trades and Movie Night in the Park, were highly successful. Special recognition goes to Kris Holcomb, her staff, the maintenance department, administration, and volunteers. The Police Department showcased River 2, the Hovercraft, the Humvee, and a squad car, receiving positive feedback from attendees.

River 2 has been removed from the river, cleaned, and stored for the season but remains available for emergencies. Maintenance and gear inventory planning will follow.

Preparations are underway for the Festival of Lights. Power line installation is expected the week of November 17, after which overnight security will begin at Veterans Park. The parade is scheduled for November 22, and the department will host drive-through events on December 24, 25, and 31. Winter Wonderland concludes January 4, 2026.

Following a Coast Guard request, TC3 reviewed five years of river-related calls. Of approximately 17,000 calls for service, at least 147 involved water responses under nine relevant nature codes. The actual number is likely higher. Work is ongoing to create a universal dispatch code for water responses to improve tracking. Commendation is given to officers for maintaining high service levels despite limited staffing, supported by administration, maintenance, and the Board.

Preparations continue for the annual Witches Walk and Veterans Day Parade. Officer Powell will drive the Humvee bearing military flags during the parade on November 8<sup>th</sup>.
