

ORDINANCE NO. 061625 - PM

**AN ORDINANCE AMENDING TITLE 6 OF THE
FON DU LAC PARK DISTRICT POLICY MANUAL**

WHEREAS, the Board of Commissioners of Fon du Lac Park District finds that the provisions of Title 6, Chapter 2 of the Fon du Lac Park District Policy Manual should be amended to modify provisions regarding unauthorized camping and adding provisions regarding the storage of personal property in public places to improve the health, safety, and welfare of the individuals using the parks, recreation areas and facilities of the Fon du Lac Park District.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE FON DU LAC PARK DISTRICT, TAZEWELL COUNTY, ILLINOIS, AS FOLLOWS:

Section 3. Title 6, Chapter 5, Section 1-A, Fines and Penalties, is hereby amended as follows:

Section 3. This Ordinance is hereby ordered to be published in pamphlet form by the Secretary of the Board of Park Commissioners and said Secretary is ordered to keep at least three (3) copies hereof available for public inspection in the future.

Section 4. This Ordinance shall be in full force and effect after its passage and 10-day period of publication in the manner provided by law.

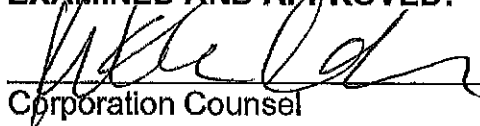
