

ORDINANCE NO. 061526 - PM

**AN ORDINANCE AMENDING TITLE 6, CHAPTER 3 OF THE
FON DU LAC PARK DISTRICT POLICY MANUAL**

WHEREAS, the Board of Commissioners of Fon du Lac Park District finds that the provisions of Title 6, Chapter 3 of the Fon du Lac Park District Policy Manual should be amended to modify provisions regarding the hours of the Park System to improve the health, safety, and welfare of the individuals using the parks, recreation areas and facilities of the Fon du Lac Park District.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE FON DU LAC PARK DISTRICT, TAZEWELL COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. Title 6, Chapter 3, Section 1, Hours of Park System, is hereby deleted in its entirety and the following substituted in lieu thereof:

6-3-1 Hours of Park System:

- (A) Except as set forth herein, no person shall be or remain in any park between one hour after Sunset and Sunrise the following day.
- (B) During April 15 and October 15, Veterans, West, and Neumann Parks hours are Sunrise to 9:00 p.m. due to shelter rentals. Attendees will be given a reasonable amount of time to clean up and vacate these parks/shelters.
- (C) The Director shall determine the days and hours of operation of the Golf Courses, Administration Center, Farm Park and Spindler Campground/Marina, Fon du Lac Drive Out-Look #1, and Brady A. Smith Park (pickleball, tennis, skate park and roller hockey rink).
- (D) The Director has the discretion to allow after hour times for scheduled community events by the Park District and organized groups (i.e., Scout troops night hiking at Spring Creek Preserve).

Section 2. Title 6, Chapter 3, Section 1, Hours of Park System, is hereby deleted in its entirety and the following substituted in lieu thereof:

6-3-2 Entry Prohibited When Closed

No person except for Park District personnel shall enter any park property to include facilities, maintenance areas, and parks after hours or when conditions indicate that such is not open to the public.

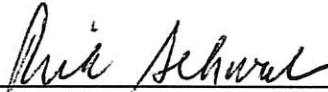
Section 3. This ordinance is in addition to all other ordinances on the subject and shall be construed therewith excepting as that part in direct conflict with any other ordinance and, in the event of such conflict, the provisions hereof shall govern.

Section 4. This Ordinance is hereby ordered to be published in pamphlet form by the Secretary of the Board of Park Commissioners and said Secretary is ordered to keep at least three (3) copies hereof available for public inspection in the future.

Section 5. This Ordinance shall be in full force and effect after its passage and 10-day period of publication in the manner provided by law.

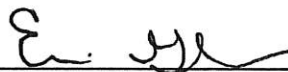

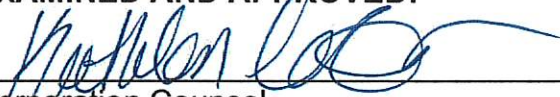
